### **Drunk Man Forces Germany To US Flight To Land In Manchester**

A 'drunk' problem passenger forced a plane flying from Germany to the United States to land in Manchester airport. The Lufthansa flight had set off from Munich for Chicago on Monday evening. However, just before 5pm the plane turned around over Ireland and headed back to Manchester to deposit a passenger who was causing difficulties. The plane landed in Manchester at 5:53 pm where it was met by officers from the Greater Manchester Police.



### Multi-Modal Cargo Hub Planned At Upcoming Noida Airport

Massive plans are underway for the under-construction airport in Noida in North India. The country's leading airport services company AISATS and Yamuna International Airport Private Limited plan to build a cargo hub at the upcoming airport's premises. There are big expectations from the airport, with an MRO facility also being set up there. Air India SATS Airport Services Private Limited (AISATS) and Yamuna International Airport Private Limited (YIAPL) - a special purpose vehicle formed for the development of the airport - have signed a concession agreement to build a state-of-the-art Multi-Modal Cargo Hub (MMCH) at Noida International Airport. The airport lies southeast of central Delhi, Gurgaon, and Noida and is almost at the halfway point to Agra, the home of the Taj Mahal.



# Flyer Caught Smoking Mid-Air On Ahmedabad-Bengaluru Akasa Air **Flight**

A flyer was detained at the Bengaluru airport on Tuesday for smoking mid-air on an Akasa Air flight from Ahmedabad. He was handed over to the police upon landing in Bengaluru, an Akasa Air spokesperson said. "A passenger on Akasa Air flight QP1326, flying from Ahmedabad to Bengaluru, was found smoking in the aircraft's lavatory. Our crew followed the required safety protocols and the passenger was handed over to the local police with the help of the Central Industrial Security Force (CISF), upon landing in Bengaluru. We are assisting authorities in investigating this matter," said the spokeperson.

## Israel Considers Regulating Police Profiling Programs At Airport

The regulation of profiling computer programs used by law enforcement for detecting drug smuggling in Ben-Gurion Airport was discussed by the Constitution, Law and Justice Committee on Sunday morning following reports that there were no legal guidelines in place. Law committee chairman Simcha Rothman criticized the police for taking five months to respond to inquiries about the legal details of their profiling system. Rothman's initial request came in response to a Calcalist article published in November. The police use a program to help analyze and flag luggage, but decisions are ultimately at an officer's discretion, said police legal advisor Gilad Bahat.

## BI To Adopt US Model In Fight Vs Human Trafficking Syndicates

THE Bureau of Immigration (BI) will apply the US model in its campaign against human trafficking syndicates that have been victimizing mostly women workers seeking better jobs abroad. Immigration Commissioner Norman Tansingco said on Sunday that would mean engaging travel agencies, airlines and shipping companies in the fight against trafficking. Tansingco said the US "collaborations among agencies are instrumental in identifying and preventing trafficking incidents."



### **Tanzania Targets High Score In Aviation Security Audit**

Tanzania is targeting to score above 86 percent in aviation security audit carried out by the International Civil Aviation Organisation (Icao) this year. High score will boost travelers' confidence and tourism performance. A four-member team of the Icao Universal Security Audit Programme Continuous Monitoring Approach (Usap-CMA) kicked off a 12-day security audit yesterday with the focus areas being the Julius Nyerere International Airport (JNIA) and Abeid Amani Karume International Airport.
