## Air Hostess Arrested On Suspicion Of Making Bomb Threat To Get Back At Ex

An Aerolíneas Argentinas air hostess has been arrested for allegedly making a call warning that a bomb had been placed on the company's flight from Buenos Aires Ministro Pistarini (Ezeiza) airport to Miami on Sunday 21, which was delayed for over nine hours. The woman was detained when she arrived in the country on her most recent flight. She is accused of making the call to both the flight commander on his personal phone and other members of the company. Ezeiza airport was placed on alert over the call, implementing a security protocol that delayed the flight's take-off. There were 270 passengers and 12 crew members on board.



## Dramatic Moment Alleged Drug Kingpin Behind One of Australia's Biggest Heroin Import Plots is Arrested At The Airport

The alleged mastermind behind one of Australia's biggest heroin hauls has been taken into custody during a dramatic arrest at a busy airport. Guy Habkhouk, 35, was detained by Australian Federal Police at [Sydney](#) International Airport on Saturday morning, for orchestrating the alleged import of 350kg of heroin in December 2020. The shipment was one of the largest in Australian history and the drugs have an estimated street value of more than \$1m.

## Stranger Hugs Germany's Scholz In Airport Security Breach

"People saying hello and greeting me is never something that particularly affects me," the Social Democrat leader said, when quizzed on the incident at a press conference in Estonian capital Tallinn. "That's very normal and I didn't find this situation dramatic either," he said of the surprising encounter on Wednesday evening.



## SAS Airlines Breached By Pro-russian Hackers – Again

For the second time this year, Scandinavian Airlines has been reportedly breached by the pro-Russian hacking group Anonymous Sudan, knocking the SAS website and its app offline for hours. SAS customers began to complain on Twitter about not being able to get on the airline's website around 6:30 am ET Wednesday morning. "Hello, yes we have technical issues with the website today, it is reported and being investigated. Please try again later, we are working on resolving the issue as soon as possible," SAS responded to most followers.



## ICAO To Remind Member States That Current STEB Usage Measures Still Apply

The International Civil Aviation Organization (ICAO) has agreed to a request by Duty Free World Council (DFWC) to issue an Electronic Bulletin reminding Member States and industry partners that current measures for security tamper-evident bags (STEBs) usage still apply until further notice. DFWC welcomed the introduction of new security technologies in many airports which enable the accurate screening of liquids, thereby strengthening aviation security and enhancing the passenger experience. However, the organisation pointed out, the global adoption of new scanner technology is set to take many years and airports will transition gradually.



## Promising Pilot Control Model To Ensure Perfect Airport Security
