Airport security liquids rule – what is changing?

Worldwide in normal times, <u>half a million people pass through airport security</u> <u>every hour</u>. Many airline passengers say it is the worst part of the journey – in particular, the need to limit LAGs (liquids, aerosols and gels) to small containers and extract them from cabin baggage. The rules were introduced hastily in 2006 as "a temporary measure" to protect against explosives. Despite repeated promises they remain in place. At airports where the technology is used, liquids and laptops no longer have to be removed. The kit was first used in Europe at <u>Shannon in the west of Ireland</u>, where "liquids, gels, pastes, lotions and cosmetics in containers of any size" have been allowed through security for over a year. Now Teesside airport and <u>London City</u> airport have the same equipment and policies.



California Man Sentenced for Assaulting Two Female Passengers on Redeye Flight to Boston

A California man was sentenced yesterday in federal court in Boston for assaulting two women aboard a redeye flight from Los Angeles to Boston.Jairaj Singh Dhillon, 43, of Modesto, Cal., was sentenced by U.S. District Court Magistrate Judge Paul G. Levenson to one year of probation, with the first six months to be served in home confinement. On March 20, 2023, Dhillon pleaded guilty to two counts of assault while in the special aircraft jurisdiction of the United States.During an overnight flight from Los Angeles to Boston on May 31, 2022, Dhillon engaged in unwanted sexual contact with two female passengers sitting next to him.



TSA at Pittsburgh International Airport Stop Two Guns in Four Days at Security Checkpoints

Transportation Security Administration officers at Pittsburgh International Airport have stopped two guns in the last four days at security checkpoints, bringing the total caught this year to 19—well on pace to set a new record for the number of guns caught in a single year. The most recent gun caught was early this morning (June 14) when a man from West Leechburg, Pa..

International Cooperation Strengthens Aircraft in Distress Tracking

The International Civil Aviation Organization (ICAO) and EUROCONTROL have deepened the cooperation between the two organizations on the safety-vital topic of aircraft in distress. The new arrangement tasks EUROCONTROL with the development and hosting of a Location of an Aircraft in Distress Repository (LADR) and an Operational Control Directory (OPS CTRL). Both will play a major part in assisting rescue efforts by coordinating all affected actors in the event of an aircraft in distress, supporting the ultimate goal of improving aircraft tracking and identifying distress situations during a flight in order to initiate a timely rescue operation.



Human Smuggling Attempt Foiled at Harlingen Airport

U.S. Border Patrol agents alongside Harlingen Police Department stopped an attempt to smuggle four migrants in an airplane on May 25. Rio Grande Valley Sector Border Patrol Intelligence agents responded to suspicious activity at Gulf Aviation at the Valley International Airport. With the assistance of the Harlingen Police Department, law enforcement personnel approached the aircraft and interrupted a human smuggling event including two pilots and four migrants determined to be in the United States illegally.

Report shows top transport cyber threats in EU

A new report reveals ransomware attacks are the most prominent threat facing the transport sector. The European Union Agency for Cybersecurity (ENISA) recently published its first cyber threat landscape report dedicated to the transport sector. The report mapped and analyzed cyber incidents in relation to aviation, maritime, railway and road transport from January 2021 to October 2022 for a total of 98 publicly reported incidents.

Austin-Bergstrom Airport to make security experience "more efficient and less stressful"

The Transportation Security Administration (TSA) and Austin-Bergstrom International Airport (AUS) have announced preliminary construction work for the installation of new Computed Tomography (CT) X-ray scanners at TSA checkpoints. The airport has four TSA security checkpoints that will each have the new screening machines at every checkpoint lane by the end of the project. These full-size CT systems feature fully automated screening lanes with sideby side stations for more passengers to place personal items in bins at the same time, automated bin return, and high threat containment. When a carryon bag is screened through a CT scanner, travellers can leave everything in their carry-on bag, including electronics larger than a cell phone and food. These new features enable passengers to move through checkpoints more quickly and with greater ease. CT units apply a sophisticated algorithm as they generate a 3D image of the contents of the carry-on bag. A TSA officer can manipulate the 3D X-ray image on-screen to allow for a better view of the bag's contents, ultimately reducing the number of bag checks that are required.
