Schiphol And Pangiam Innovate With Artificial Intelligence Powered Technology

As revealed at the [FTE Digital, Innovation & Startup Hub](#) event in Amsterdam on 13 March 2023, Royal Schiphol Group is starting a collaboration with security technology company Pangiam to develop a new way to screen hand baggage quickly and safely. The new technology, powered by Artificial Intelligence, could eventually help enable travellers to go through security checks faster, without compromising on safety. The aim of the collaboration is to explore how Pangiam's new technology can improve and speed up hand baggage screening. The technology uses Artificial Intelligence and algorithms to analyse images of hand baggage and identify prohibited items and other security risks. In the future, the technology could support employees in this and speed up the process for travellers.



Increased Penalties Fail to Deter Travelers

Despite increased penalties, Transportation Security Administration (TSA) officers are continuing to see a large number of firearms at checkpoints, most of which are loaded. On August 3, TSA officers prevented a male passenger from carrying a loaded firearm onto an airplane at Tweed New Haven Airport. During routine screening, the firearm was detected in the passenger's carry-on bag. TSA immediately notified the New Haven Police who quickly responded and discovered a loaded 9mm with a round chambered in the 46-year-old passenger's backpack. During the interview, the South Carolina resident stated he was in a rush and forgot to put the firearm in his checked luggage. The passenger ended up missing his flight.



Report Shows Top Transport Cyber Threats In EU

A new report reveals ransomware attacks are the most prominent threat facing the transport sector. The European Union Agency for Cybersecurity (ENISA) recently published its first cyber threat landscape report dedicated to the transport sector. [The report](#) mapped and analyzed cyber incidents in relation to aviation, maritime, railway and road transport from January 2021 to October 2022 for a total of 98 publicly reported incidents.

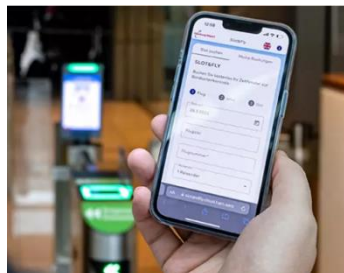
Edinburgh Airport to Install Next-generation Security Scanners
