Woman Arrested At Larnaca Airport After Police Find Drugs In Her Luggage

Police at Larnaca Airport arrested a 24-year-old woman yesterday who was allegedly found carrying drugs in her luggage. The arrest was made as part of a collaborative effort between the anti-drug squad (YKAN) and customs authorities. The woman, arriving from another country, was stopped for inspection around 8:30 p.m. yesterday. Upon examining her luggage, officials uncovered eight nylon packages containing a total of 8 kilograms and 957 grams of cannabis.



IndiGo Airlines Staffer Arrested With 33 Gold Bars Worth ₹2.13 Cr At Airport; Visuals Surface

An IndiGo airline ground staff was arrested with 33 Gold Bars valued over Rs 2.13 crore by the customs air intelligence unit (AIU) on the intervening night of 11-12 December at Mumbai Chhatrapati Shivaji Maharaj International Airport. The 10 tolas 33 pieces of 24 KT gold weighing 3845.00 grams were seized from the IndiGo airlines ground staff under close surveillance for several days on intelligence developed by the Mumbai Customs of developed intel about the smuggling racket of Gold from the airport tarmac and inline area of the airport by the ground staff employed for handling the passenger baggage.



Delhi Airport To Install Full-body Scanners And CTX Machines By May Next Year

[Delhi Airport](#) is set to have full-body scanners in place by May 2024, as reported by PTI news agency citing a senior official. Additionally, Computed Tomography X-ray (CTX) machines, allowing passengers to keep electronic items in their hand baggage during security checks, are also expected to be operational by the same time. Hasan noted that the deadline for implementing [full-body scanners](#) at airports with over 10 million annual passengers and CTX machines at those with over 5 million passengers is currently being extended. Earlier, the deadline for installing the full body scanners and CTX machines at airports was given as December 31.



Businessman Freed of Drug Charges In Relation To Cocaine Found In Oats At Airport

Businessman Mordecai Buckley was freed in in the Kingston and St Andrew Parish Court on charges of possession of cocaine, attempting to export cocaine, conspiracy to export cocaine, dealing in cocaine and trafficking. He was found not guilty after a no-case submission by his attorneys Peter Champagne KC and Samo Campbell was upheld by presiding judge Paula Blake Powell.



Security Threat At Nelson Airport - Passengers Evacuated

A security threat has been reported at Nelson Airport this morning, leading to passengers being evacuated at about 9am. In a statement, police said they were at Nelson Airport after receiving an email of a concerning nature. After evacuating passengers, the police said just after 10.30am the airport had been cleared and is resuming normal operations. Both the airport and planes there have been cleared and Police are confident there is no ongoing threat. The police are working to establish the origin of the email. Police initially advised the public to avoid the airport until the incident was resolved, and to follow instructions from their airline.



Man To Plead Guilty To Making Bomb Threat On Scoot Flight

A man who allegedly made a bomb threat on a Scoot flight from Singapore to Perth in October, thus forcing the plane to turn back to Singapore under fighter jet escort, is set to plead guilty next month. Hawkins Kevin Francis, 30, appeared in court through video link on Monday (Dec 18) where he was represented by defence counsel Dhillon Surinder Singh. The Australian was earlier charged on Oct 14 under the United Nations Act for making a false bomb threat while onboard an aircraft. On the afternoon of Oct 12, the police were alerted to a bomb threat made on board Scoot flight TR16, which was en route from Singapore to Perth, Australia. During the flight, Hawkins allegedly told a male cabin crew member: "I have a bomb."



14 Tenerife South Airport Workers Arrested And 20 More Investigated For Stealing Nearly 2 Million Euros From Passengers' Suitcases

At Tenerife South Airport, 14 employees were arrested and 20 more were investigated for allegedly stealing nearly 2 million euros from passengers' checked suitcases. The accused, workers of various companies at the airport, formed a criminal group involved in theft, money laundering, and damages. They exploited their roles at the airport by tampering with suitcases in the plane's holds, discreetly opening and puncturing zippers to steal items like jewellery, electronics, and cash. They strategically placed the suitcases to conceal their actions and prevent detection.



Anonymous Arabia Declares Cyber Assault on Abu Dhabi Airport, UAE's Second Busiest

A mysterious cybercriminal group, Anonymous Arabia, has targeted Abu Dhabi Airport, leading to its alleged shutdown. The gravity of the situation is heightened by the fact that Abu Dhabi Airport ranks as the second busiest airport in the UAE, following Dubai Airport. The claimed Abu Dhabi airport cyberattack has the potential to cause significant disruptions to the daily operations of a vital airport in the Middle East. Nevertheless, the details surrounding the Abu Dhabi Airport [cyberattack](#) remain veiled in mystery, as the group has not disclosed any additional information. The Cyber Express team attempted to access the [Abu Dhabi Airport](#) website to verify these assertions. The website appeared to be functioning normally.
