



Self-Radicalised Singaporean Youth

A 16-year-old male Singaporean was issued with a RO under the ISA in Nov 2023. The youth is the second Singaporean to be dealt with under the ISA for being radicalised by far-right extremist ideologies. The youth, although of Chinese ethnicity, identified as a white supremacist, and aspired to conduct attacks overseas in furtherance of the white supremacist cause. He was exposed to violent extremist material online in 2022 and developed an intense hatred of communities typically targeted by far-right extremists, including African Americans, Arabs and LGBTQ+ individuals by early 2023.



Two Bangladeshi-born American passport holders have been arrested at Hazrat Shahjalal International Airport with \$100,000. They were carrying the dollars without any endorsement. The detained passengers were identified as Md Rezaul Karim Khan and Md Jashim Uddin Khan. They were supposed to go to the United States on Friday on a flight of Qatar Airlines (QR 641). A team of customs officials seized the dollar from two passengers when they were scheduled to leave Dhaka airport on the flight, according to airport sources. A case was filed on Friday night. They are currently in the custody of the airport police station.





Unruly Passengers Were A Problem Before The Pandemic. Now They're Even Worse



Passenger Philip Baum recently experienced one of the most uncomfortable flights of his life. To Baum, it was obvious his seatmate, a stranger, was drunk. Flight crew, he says, "denied him alcohol." "But in front of me, he managed to sneak more alcohol off the trolley," Baum recalls. For Baum, who was seated in the economy cabin, being in such close proximity to the "unruly" passenger for multiple hours wasn't pleasant. "I actually thought I'd throw up," he tells CNN Travel. "The guy pulled out his nails. He was bleeding. He stank, and he was blind drunk."

Former Polar Air Cargo Exec Pleads Guilty To Wire Fraud

A former vice president at Polar Air Cargo pleaded guilty last week to participating in a scheme to defraud the company of \$52 million for more than a decade. Six of nine individuals charged in the plot have presented guilty pleas so far. Polar Air Cargo is a joint venture between privately held Atlas Air Worldwide and DHL Express. According to aircraft database Planespotters.net, the airline has a fleet of 15 large Boeing cargo jets: six 747–8s, two 767–300s and seven 777s.Carlton Llewellyn, 55, who was in charge of operations systems performance and quality, pleaded guilty last week to one count of wire fraud in the U.S. District Court for the Southern District of New York, federal prosecutors announced.





European Aviation Regulator Teams Up With IATA on Jamming Threat



Europe aviation officials and the airline industry are teaming up to curb the threat posed by jamming, instances where the satellite signals planes rely on for navigation are drowned out or disrupted. The European Union Aviation Safety Agency and the International Air Transport Association, a trade group, hosted a meeting in Cologne on Thursday, where officials from airlines, manufacturers, suppliers and other industry participants met to discuss ways to reduce the risks. Incidents of jamming and spoofing — where false signals are sent — are on the rise due to wars in Ukraine and the Middle East, as combatants seek to divert enemy aircraft. The practices can inadvertently affect commercial jets, and risk pushing them off course into dangerous conflict zones.

Facial Recognition Technology At Airports Divides Experts



Your face is about to become your ticket. Airports in Spain are standardizing facial recognition, a technology that will allow users to speed up their passage through security controls without having to take out their documents or boarding pass. However, adopting this measure raises concerns about their security and privacy. Vueling was the first airline in the country to implement this controversial identification method. In 2021, he launched the pilot program developed by AENA in Barcelona and, after deeming it a success, decided to install it at the airport of the Catalan capital and the airports of Madrid, Menorca, Palma de Mallorca and Ibiza. He announced on Wednesday that he would "soon" expand his scope to include the northern regions of Gran Canaria and Tenerife. Other airlines, such as Air Europa, Inter and Iberia, are also participating in this initiative.

The Delhi Police has arrested a fraudster operating a fake passport and visa racket at Indira Gandhi International Airport. The police received information about the fraudster through the arrest of one passenger carrying a fake passport at the airport. The arrested accused was identified as Mujeeb PP (49), resident of Perashannur, Kuttipuram, Malappuram district, Kerala. According to the police, the investigation of the case registered on March 14, 2019, involving a passenger named Vishal Khullar from Jodhpur, Rajasthan. Khullar, carrying a passport valid until August 29, 2026, had received departure clearance to Madrid, Spain, based on a Schengen Visa.





Nigerian Returnee From Brazil Excretes 60 Wraps of Cocaine At Lagos Airport



A Nigerian returnee from Brazil identified as Udechukwu Ekene Theophilus has been arrested by the National Drug Law Enforcement Agency (NDLEA) for ingesting 60 wraps of cocaine. The suspect was arrested at the Murtala Muhammed International Airport in Lagos on Sunday, January 21, 2024, during the inward clearance of passengers on an Ethiopian Airlines flight from Sao Paulo, Brazil via Addis Ababa, Ethiopia.
